### WINTER/SPRING 2023 UPDATES

*Hello Neighbor/Friend* - We hope you have been enjoying a warmer than usual winter season and are doing well. We snowmobilers/skiers are not sure what to make of this!

I am happy to report the Town's Q3 2022 Sales Tax collections were \$432,401.18. This is \$130,000+ higher than the Q3 2022 budget estimate. Also, the Town's Q4 2022 Sales Tax collections were \$ 322,632.93. This is \$22,000+ higher than the Q4 budget estimate. The Town continues to see a healthy surplus in its General Fund.

During Q3 and Q4 of 2022, the Sennett Town Board has accomplished the following:

- Held public information sessions for proposed WD 1 & 3 water improvement; projects and awarded bids for a re-designed less costly project;
- Bid-out and awarded the Veteran Affairs/Town Historian Office project;
- Attended Sennett Seniors lunch meetings;
- Worked with Cayuga County Planning to update the Town's HL Overlay District and appointed an Ad Hoc committee to oversee zoning updates to the District;
- Adopted local laws to include a moratorium on commercial Solar Energy projects so the Town's Solar law can be updated;
- Approved the completion of Town Hall window replacements;
- Met with other Cayuga County municipal leaders to discuss sewer and water issues;
- Worked on Town special district projects and billing issues;
- Attended a ribbon cutting for the Senior apartment project "Sennett Meadows";
- Continued meeting on Town of Sennett branding and marketing;
- Interviewed and hired a new Town Code Enforcement Officer;
- Welcomed our new/returning ZBA and Planning Board members, including new Planning Board Chairman Patrick Leamy;
- Interviewed candidates and hired a new Water & Sewer Department employee;
- Plan for and approve parking lot replacement project;
- And of course handled day to day issues in the Town as they arose.

# Water District(s) 1 & 3 Improvement Project

The originally designed waterline replacement, installation, and Water Tank project came in well over budget and was redesigned, bring the costs from \$ 6,581,000 to \$3,747,00 (including soft costs). WD 1 & 3 residents will realize the benefits of some waterline expansions and replacements, but not a water tank. Work is due to begin in the Spring and residents will have notice of work beginning on their road at least one week in advance.

### Water & Sewer Dept.

As of January 1, 2023, the City of Auburn has increased our Sewer rate by 6.5%. As a result, sewer customers will see an increase on their sewer rates of 6.5%, beginning the first quarter billing cycle that will be mailed out in early April. The City of Auburn will also be increasing our water costs by 15% as of 5/1/23. As a result of this increase, water customers will see an increase on their water bills beginning the second quarter billing cycle of the year, which will be mailed out in early July.

We have continued to replace water meter heads throughout our water districts, and have established a watermain flushing plan, and a hydrant maintenance schedule. We will be replacing the district



3 watermain meter in the coming weeks. We have recently submitted our cybersecurity plan to New York State for approval.

We have newly installed & updated Water/Sewer District maps posted in the Town hall for residents to view.

# **Town Clerk**

2023 Tax Collection continues through March 31, 2023. The Clerk's office is open Monday – Friday, 9 am – 4pm. Tax payments can be mailed in by sending to Sennett Tax Collector, 6931 Cherry Street Road, Auburn, N.Y. 13021. Payments can also be made in person at the Clerk's office during the hours listed above or left in the Town Clerk's "Drop Box" located next to the front door. If you are unable to make your payment during the scheduled office hours noted above, please call 315-253-3712 ext. 1 to schedule an appointment.

New York State requires that all dogs over the age of 4 months must be licensed. New licenses must be obtained in person, whereas annual renewals may be submitted by mail. To obtain a license, the owner must provide to the Town Clerk's office veterinary documentation of a current rabies vaccination and, if spayed or neutered, the certificate issued by the surgeon who performed the procedure. You can license your spayed or neutered dog for \$8.50 per year or your un-spayed or unneutered dog for \$18.50 per year as long as their rabies shot is valid. Be proactive. Dog enumerations are expensive and fines are charged to unlicensed dog owners.

Free at-home COVID-19 test kits continue to be available at the Town Clerk's office.

- 1. Auburn Associates subdivision.
- 2. A preliminary site plan for Auburn Auto Group for a property located at 325 Grant Avenue Road.
- 3. A preliminary review for a proposed subdivision for a property located on Depot Road.
- 4. A preliminary site plan review and SEQRA review for Owens-Brockway located at 7134 County House Road. This project is for a Oxygen Gas combustion melting furnace or production of sustainable glass containers, the first phase is roughly a \$50M project.

# **Zoning Board of Appeals**

This 5-member board recently underwent changes due to the resignation of Harold Gilfus, who became the Town's Code Enforcement Officer, and also due to the "terming out" of Sue Foster's ZBA term. The ZBA has welcomed new members Robert Steiner and Dennis Sherry as regular members. The Town is currently seeking 2 ZBA alternates to serve on an as needed basis! As a reminder, your ZBA works impartially as a zoning and land use appellate board. It hears appeals from decisions of the Codes/Zoning Office and reviews area and use variance requests. The ZBA may also evaluate special permit applications. It functions as a "safety valve" to relieve the pressure of inflexible zoning provisions and has the power, on appeal, to interpret zoning codes or local laws and to grant variances. In essence, the ZBA is called upon to issue final decisions on many of the Town's most difficult zoning law interpretations. The board strives to adhere to Town precedent.

### PROJECT LIFESAVER<sup>®</sup> Bringing Loved Ones Home

Through a Partnership with Cayuga County Office for the Aging and Cayuga County Sheriff's Department, Project Lifesaver is a rapid-response rescue program for individuals who are <u>at risk</u> of <u>wandering</u> and becoming <u>lost</u>. Each participant is fitted with a personalized Project Lifesaver wristband. This unique wristband is a one-ounce battery-operated transmitter that emits an automatic tracking signal.

When needed, this signal can be <u>tracked</u> by specially trained personnel in the Cayuga County Sheriff's Department on the ground or in the air. Search time has typically been reduced from hours and days down to minutes.

### **Sennett Fire Department**

The Sennett Fire Department experienced a near record year in 2022, responding to 407 calls for service. As part of the National Fire Incident Report System (NFIRS) incident categories, we reported 24 fires (includes structure, vehicle, and outdoor fires); 236 rescue and Emergency Medical Service (EMS) which includes motor vehicle crashes; 21 hazardous conditions, 30 service calls, 61good intent calls, 33 false alarms and 2 severe weather-related calls.

#### Statewide Open Burn Ban

The annual statewide ban prohibiting brush burning begins on March 16 and extends to May 14. Open burning—as in outdoor fires, burn barrels, backyard incinerators, or any fire that's not vented through a stack or chimney—is not allowed, with few exceptions. Open burning is the single greatest cause of wildfires in NYS. Since the spring burn ban was implemented in 2009, the number of wildfires has decreased by more than 40%. Burning loose leaves or leaf piles is illegal.

#### **Outdoor Cooking**

Outdoor barbecue grills of many types are popular. Roughly 70% over U.S. households own at least one outdoor BBQ grill or smoker. According to the National Fire Protection Association, 9,600 home fires are started by barbecue grills each year, on average. July is the peak month for grill fires, followed by May, June, and August. Over 16,000 people are treated for grill related injuries each year with over half being thermal burns.

**Grilling:** Keep barbecue grills far away from anything that can burn -- your home, cars, dry vegetation, etc. Stay with the grill when it is lit and keep children and pets well away from the area. When barbecuing, protect yourself by wearing a heavy apron and an oven mitt that fits high up



over your forearm. If you get burned, run cool water over the burn for 10 to 15 minutes. (Tip: Don't use butter or a salve on burns because these seal in heat and can damage the tissue further.) If you receive a serious burn, with charred skin, for example, seek medical attention promptly. Barbecue grills must never be used inside the home because, in addition to the fire hazard of indoor grilling, the grill can easily cause carbon monoxide poisoning. If lightning appears while you are grilling, seek shelter and wait for the storm to pass.

#### **Gasoline Safety**

Store gasoline outside the home, preferably in a locked, detached shed, and store just enough to power your gasoline-fueled equipment. Keep gasoline up high, inside a clearly marked container that is labeled and approved for gasoline storage. Make sure gasoline and all flammable liquids are well away from any heat source or flame. Use gasoline as a motor fuel only - never as a stain remover or for other purposes. To transport gasoline in an automobile to and from the filling station, place a sealed, approved container in the trunk with the trunk lid propped open and drive directly to the fueling site. Take a direct route back home and never store gasoline in a vehicle. Extinguish smoking materials before fueling and take the equipment outside well away from combustibles. Wipe up any spills immediately and move the equipment at least 10 feet away from the fueling area to start the engine. Before re-fueling, turn off the equipment and let it cool completely.

# Public Safety Update Reverse 911

The Cayuga County Sheriff's Department and E-911 Emergency Communication Department encourage residents to sign up for Community Mass Notification Messages. This sends out alert notifications of emergency situations such as boil water advisories, inmate breaches, missing persons, or any situation that would require a mass notification in a short period of time. Verizon provides landline numbers to the service but cell phones need to be registered.
